## **Management of Communication Resources**

### **1.1 OVERVIEW.**

Thank-you Bob. Good evening, to the net. Tonight, I'll be discussing the management of communication resources prior to and during an activation event.

### **1.2 OVERVIEW**

Pinellas County ACS uses two forms to manage the communication resources and frequencies prior to and during an activation event. The first is the ICS 217A Communications Availability Worksheet and the second is the ICS 205 Communications plan. Tonight, I'll be discussing the ICS 217A.

### **1.3 ICS 217A COMMUNICATIONS RESOURCE AVAILABILITY WORKSHEET**

The purpose of the ICS 217A is to identify all the amateur radio repeaters, digipeaters, Winlink RMS Gateways, and simplex frequencies accessible and available for use by Pinellas County during an activation event. It is the master list of all the resources that could potentially be used. It is not a list of the resources that will be used.

Prior to an activation event, the ACS Leadership team will use this master list of resources to build a communications plan that is appropriate and meets the needs of the specific event. For example, a public service event like a 10k run may only require a single repeater and a single simplex frequency to meet the communication needs of the event. While a major weather event may require multiple VHF/UHF repeaters, back-up repeaters, and HF networks.

The ICS 217A used by the Pinellas County ACS is located within appendix F of the PinCo ACS Emergency Communications Plan and Standard Operating Procedures Document. This document is located on the PACS Website.

An individual worksheet has been created for each RF band and Function. So, when you review Appendix F, you will find individual worksheets for VHF Repeater, UHF Repeater, Winlink RMS

Gateways, APRS Digipeaters, HF and VHF simplex frequencies; and the repeater frequencies for all West Central Florida County EOCs.

Each worksheet contains all the information needed to establish and maintain communications using the identified repeater, RMS gateway, or simplex frequency. The form has a frequency band and description field that is common to all the entries on the form and nine fields that uniquely describe each communication resource.

So, first I'll describe the two common fields that are located at the top of the form.

- a. **Frequency Band:** The frequency band (e.g., 80-Meters, 40-Meters, 6-meters, 2-Meters, 70 cm, VHF, UHF, 700 MHz, or 800 MHz, etc.)
- b. **Description:** This field contains a description of the information entered on the worksheet (e.g., UHF Repeater Systems Accessible from Pinellas County).

As mentioned previously, there are nine fields that describe each communications resource.

- a. **Channel Configuration:** This field contains a general description/purpose of the channel (e.g., Repeater, Linked-Repeater, Simplex, Simplex-Mobile Only, Simplex-Base/Mobile, etc.).
- b. **Channel Name/Trunked Radio System Talk Group:** The commonly used name for the channel. When the entry identifies a repeater, the repeater call sign will be entered into this field. When the entry corresponds to a simplex frequency, the intended purpose of the frequency will be entered (e.g., PACS Plan B).
- c. **Eligible Users:** Who is permitted to use the channel. In most cases, this entry will be listed as Amateur; however, I have included at least one GMRS repeater in the set of worksheets. So, in that case, it would list GMRS.

The next set of fields detail the technical elements of the entry. The first of these entries detail the receive frequency and bandwidth.

- d. **RX Freq N or W:** This field contains the receive frequency as the mobile or portable radio would be programmed. The bandwidth is listed as either (N) for

narrow, or (W) for wide. Except for digital modes, this entry will almost always indicate wide.

- e. **RX Tone/NAC:** Depending on the type of resource being described, this field can contain several different types of information. The receive Continuous Tone Coded Squelch System (CTCSS) subaudible tone, Digital Coded Squelch (DCS), Network Access Code (NAC), Radio Access Code (RAN), or Color Code (CC) for the receive frequency as the mobile or portable radio would be programmed. If no tone/code is required, the field will indicate that the radio should simply use a Carrier Squelch (CSQ).

This information is also repeated for the transmit function of the entry.

- f. **TX Freq N or Wide:** There is an entry for transmit frequency and bandwidth. The transmit frequency as the mobile or portable radio would be programmed. The bandwidth is listed as narrow or wide.
- g. **TX Tone/NAC:** The transmit CTCSS subaudible tone, DCS, NAC, RAN, or CC for the transmit frequency. If no tone or code is required, Enter CSQ.

The final two fields are *operating mode* and *remarks*.

- h. **Mode:** The mode field will have a single letter entry: “A” for analog operation, “D” for digital operation or “M” for Mixed mode operation (e.g., Analog and Fusion).
- i. **Remarks:** This field can contain any additional information that might be beneficial to the leadership team during planning activities. Examples include repeater location, modes of operation (e.g., D-Star, NXDN, P25, Fusion, DMR), or a dedicated purpose such as PACS Shelter Net.

Now as you can imagine, maintaining a master list of communications resources for the county can be a bit of a challenge. Repeaters come and go or change modes of operation. Web sites are not always kept up to date with the latest information. So, it’s important for everyone to review the current ICS 217A that’s contained in the communications plan. If you see an error or

a missing resource, please send me a note so that we can correct the entry. The worst time to find out we have an error is when we're rushing to generate a communications plan to support an emergency activation.
